- of **Government Decision no. 562/2017** on the declaration of the project " Development of the capacity of the National Transmission System in order to ensure the flow of natural gas in the direction Romania - Republic of Moldova" as a project of national importance in the field of natural gas,
- of **Law No 50/1991** on the authorisation of construction works, republished, as subsequently amended and supplemented,
- of the **Order of the Minister of Regional Development and Housing No 839/2009** approving the Methodological Rules for the application of Law No 50/1991 on the authorisation of construction works, as subsequently amended and supplemented.

AUTHORISATION IS HEREBY GRANTED

to carry out construction works for:

on the property - land and/or buildings located in **BACĂU, NEAMŢ and IAȘI** counties:

1. **The Onești-Gherăești natural gas transmission pipeline** is located on the administrative territory of the city of Onești and the communes of Bârsănești, Helgiu, Livezi, Sănduleni, Berești-Tazlău, Strungari, Mărgineni, Blăgești, Gărleni, Racova and Filipești - Bacău county, and the communes of Bahna, Moldoveni, Secuieni, Trifești, Horia, Dulcești, Cordon, Săbăoani and Gherăești - Neamț county;
2. **The Gherăești-Lețcani natural gas transmission pipeline** is located outside the municipality of Gherăești - Neamț county, and in the towns of Târgu Frumos, Podul Iloaiei and the municipalities of Mircești, Răchiteni, Butea, Alexandru Ioan Cuza, Strunga, Ion Neculce, Bălțați and Dumești - Iași county;
3. **Onești Natural Gas Compressor Station (SCG)** - located outside the town of Onești (Bacău County) on a location near the existing **Onești Compressor Station**;
4. **Gherăești Natural Gas Compressor Station (SCG)** located in the outside of the built up area of Gherăești commune - Neamț county;

THE FOLLOWING POINTS ARE MADE WITH REGARD TO AUTHORISING THE EXECUTION OF THE WORKS -

- A . The Technical Documentation - T.D. (D.T.A.C. + D.T.O.E.) - endorsed for non-change - together with all the opinions and agreements obtained, as well as the point of view/administrative act of the competent authority for environmental protection, is an integral part of the present authorisation.**

Failure to comply with the technical documentation of the T.D. - aimed for non-change (including the approvals and agreements obtained) constitutes an offence or contravention, as the case may be, under the provisions of Article 24 paragraph (1), respectively Article 26 paragraph (1) of Law no.50/1991 on the authorization of construction works, republished.

in accordance with the provisions of Article 7 paragraphs (15) - (15*) of Law no.50/1991 and in compliance with the legislation for the implementation of Council Directive 85/337/EEC (EIA Directive) on the assessment of the effects of certain public and private projects on the environment, if during the execution of the works and only during the period of validity of the construction permit there are changes in the subject matter of the authorised construction works, which lead to the need to modify them, the holder is obliged to apply for a new construction permit.

B. The authorisation holder shall be obliged to:

1. Give notice of the date of commencement of the authorised works by sending the notice in accordance with the form attached to the permit (model form F.13) to the local administrative authority

issuing the permit;

2. To announce the date of commencement of the authorised works, by sending the notification in accordance with the form attached to the authorisation (model form F. 14) to the Territorial Building Inspectorate, together with proof of payment of the legal fee of **0.1%** of the authorised value of the construction works and related installations;

3. To announce the date of completion of the authorised works, by sending the notification according to the form attached to the authorisation (model form F.15) to the Territorial Building Inspectorate, once the acceptance committee has been convened.

Keep the building permit and technical documentation in perfect condition on site. **DT (DTAC+DTOE/DTAD)** aimed for non-change, together with the FEED - P.Th. and the execution details for the execution of the authorised construction works, which he will present at the request of the inspection bodies, according to the law, throughout the execution of the works;

4. If, during the execution of the works, archaeological remains are discovered (fragments of walls, anchorages of voids, foundations, carved or sculpted stones, bones, monetary inventory, ceramics, etc.) to stop the execution of the works, to take security and protection measures and to immediately notify the issuer of the authorization, as well as the County Directorate for Culture, Cults and Heritage;

C. PERIOD OF VALIDITY OF THE CONSTRUCTION PERMIT shall be **36 months** from the date of issue, provided that work is started within **12 months** of the date of issue.

The commencement of the works within the timeframe stipulated in the *Construction Permit* shall extend the validity of the *Construction Permit* for the entire duration of the works stipulated in the permit.
