REPORT

regarding Q IV 2019 SNTGN TRANSGAZ SA Medias procured assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services)

SUMMARY

Considering Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, the Report contains information regarding Q IV 2018 procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services), for the publication on the Company`s website within 5 days from submission at the Bucharest Stock Exchange of the Quarterly Report prepared according to the provisions of Art. 227 of Law 297/2004 on capital market, as further amended and supplemented.

DETAILED CONTENT

Considering Order 278/09.03.2015 of the Minister of Economy, Trade and Tourism, Art.1 (1), the summarized records is presented in Annex 1 and Annex 2 of the Report regarding the procurement of assets, services and works having a value higher than EUR 500,000/procurement (for the procurement of assets and works) and EUR 100,000/procurement (for services).

The procurements are based on the annual plans of sectoral procurements, approved by Resolution no. 3/31.01.2019 of the Board of Administration, namely on the **2019 Annual Plan of Sectoral Procurements (PAAS 2019)** with the value of **Lei 2,723,171,227.46**, and the **2019 Annual Plan of Sectoral Procurements - NTS developments in North-East Romania for enhancing gas supply to the area and for ensuring transmission capacities to the Republic of Moldova (PAAS 2019 - Moldova)**, amounting to **Lei 890,330,194**.

Following 29 updates of PAAS 2019 necessary after the revision of the execution programmes at the basis of the revenue and expense budget, the total value of the PAAS was of **Lei 2,974,188,417.33**, and the value of **PAAS 2019 – Moldova** was of **Lei 933,148,303.00 lei**.

The procurements presented in Annex 1 and Annex 2 of the Report were performed according to Law 99/2016 on the sectoral procurements and the Methodological norms for application approved by GR 394/2016, as further amended and supplemented, by open tender and simplified procedures, published in the Electronic Public Procurement System (SEAP), and by negotiated procedures without prior call for competition.

In Q IV 2019 assets, services and works procurements **in Lei** were concluded as follows:

- 2 (two) procurements of **works**, having an aggregated value of **Lei 5,591,902.96**
- 4 (four) procurements of **assets**, having an aggregated value of **Lei 45.945.195,49 lei**
- 5 (five) procurements of **services**, having an aggregated value of **Lei 14.595.136,54 lei**

Also, in Q IV 2019 procurements **in Euro** were concluded as follows:

- 2 (two) procurements of **works**, having an aggregated value of **Euro 75,601,729.69**
- 2 (two) procurements of **assets**, having an aggregated value of **Euro 31,014,004.96**
- 1 (one) procurements of **services**, having an aggregated value of **Euro 2,020,950.00**
