REPORT

on the approval of the proposal for the discharge from administration of the administrators of SNTGN Transgaz SA for the activity carried out in 2022

SUMMARY

The activity carried out as well as the economic-financial results achieved by Transgaz in 2022 are presented in the Annual Consolidated Report of the Board of Administration compared to the activity and the results related to 2020 and 2021 as they are contemplated in the annual consolidated audited financial statements for the financial year 2022.

Following the endorsement of the annual financial statements for the financial year ended 31.12.2022, based on the Report of the statutory Auditor and on the consolidated Annual Report of the Board of Administration for 2022, according to the legal provisions we are required to put forth the discharge from administration of the administrators as far as the activity carried out in 2022 is concerned.

PROPOSAL

Based on the following legal provisions:

- Art.111, paragraph (2), letter (d) of Companies' Law 31/1990, republished as amended;
- Chapter IV, Art. 15, paragraph 3, letter (h) of the updated Articles of Incorporation
 of the National Gas Transmission Company, we submit for the approval of the

 from the administration of Transgaz' administrators for the activity carried out in the
