The scope of the Independent Auditor's Report

We have been appointed by S.N.T.G.N. Transgaz S.A. ("th in the Current reports from January 22, 2018, February 07, 2018, February 26, 2018, March 12, 2018, March 13,2018, May 30, 2018, August 17, 2018, September 18, 2018, October 02, 2018, October 11, 2018, October 26, 2018, October 30, 2018, November 14, 2018 ("Current Reports") issued by the Company in accordance with the provisions of Law related to the issuers of financial instruments and market operations (Law no 24/2017) and article 144, B) of the Regulation no. 5/2018 of the Financial Supervisons on the feature of the supervisons of the supervisors of the s

The Current Reports from January 22, 2018, February 07, 2018, February 26, 2018, March 12, 2018, March 13,2018, May 30, 2018, August 17, 2018, September 18, 2018, October 02, 2018, October 11, 2018, October 26, 2018, October 30, 2018, November 14, 2018 have been prepared by the management of the Company to report to ASF in accordance with the provisions of art. 82 from Law no 24/2017 and Regulation no. 5/2018.

Management's responsibility

Management is responsible for the preparation and fair presentation of the Current Reports and of the transactions included in them that are free of material misstatement, in accordance with art. 82 from Law no 24/2017 and Regulation no. 5/2018, and for the information presented in these reports. This responsibility includes: designing, implementing and maintaining an internal control relevant to the preparation and presentation of the Current Reports that are free of material misstatement, due to fraud or error. Also, this responsibility includes compliance with the provisions of art. 82 from Law no 24/2017 and Regulation no. 5/2018 and maintaining adequate supporting documents regarding the Current Reports. Management is responsible for preventing and detecting fraud and ensuring compliance with the legislation and regulations in force.

Auditor's responsibility

Our responsibility is to analyze the reported transactions included by the Company in the Current Reports and to report in the form of an independent conclusion of limited assurance, based on the evidence obtained. We conducted the engagement in accordance with International Standard on Assurance Engagements (" | S A E ") 3000 a s adopted bу the Romanian Γi engagement other than Audits or Reviews of Historical Financial Information. This standard require that we comply with ethical requirements, including independence requirements, and plan and perform our procedures in order to obtain a corresponding assurance level of whether the transactions included in the Current Reports, are in accordance, under all material aspects, with art. 144 B) of Regulation no. 5/2018, as a basis for our independent conclusion of limited assurance.

We apply the International Quality Control Standard 1 (ISQC 1) and, consequently, maintain a solid quality control system, including policies and procedures that document compliance with relevant ethical and professional standards and requirements in legislation or regulations.



We respect the independence requirements and other ethical requirements of IESBA's Accounting Ethics Code of Ethics, which sets out the fundamental principles of integrity, objectivity, professional competence and due care, confidentiality and professional conduct.

The selected procedures depend on our understanding of the Current Reports and of other circumstances of the engagement, as well as our considerations on areas where material misstatements may occur. In developing our understanding on the Current Reports and on the transactions reported in the Current Reports we took into considerations of art i on the Company's internal the Current Reports in accordance with the provisions of art. 82 of Law no. 24/2017 and Regulation no. 5/2018 in order to establish the procedures that are appropriate in these circumstances, but not for the purpose of expressing a conclusion on the effectiveness of internal control for the preparation and fair presentation of the Company's Current Reports and the transactions reported in the Current Reports

Limited assurance is narrower than absolute or reasonable assurance. The procedures for obtaining evidence for a limited assurance engagement are more restricted than in a reasonable assurance engagement, and therefore the level of assurance obtained is lower than in a reasonable assurance engagement.

As part of this engagement, we have not performed audit review or verification procedures of the Current Reports and on the transactions reported in the Current Reports in accordance with the International Standards on Auditing or International Standards on Review Engagements adopted by the Chamber of Financial Auditors of Romania, nor on the sources from which the Current Reports and the transactions reported in the Current Reports were extracted. Our procedures were only performed in connection with the Current Reports. We have not performed other additional procedures to verify whether the Current Reports include all contracts with managers, employees, shareholders, as well as their affiliated entities, to be reported according to art. 82 of Law no. 24/2017.

Criteria

Regarding the Current Reports, we performed the following procedures:

- We obtained from the Company the current accompar are required to be included in these reports under Law 24/2017 (Article 82) with the information that was included in these reports by the Company.
- F o r aion of eReports that we have reviewed, as defined in this report, we determined whether their details correspond to all significant aspects of the information contained in the contracts made available to us.
- To the extent that the goods or services provided etc the Company's for directors, its significant staff and shareholders and the persons involved with them, we have discussed with the management of the Company how the prices of the contracts were set and if, on a case-by-case basis, the agreed prices correspond to those used by other parties (third parties), services or similar goods. If there are no available market prices, we have analyzed whether those transactions are made based on approved and signed contracts.
- Fcontracts involving the application of regulated tariffs, we compared the tariffs applied with those in force at the date of conclusion of the respective contracts.

Basis for qualified conclusion

Following the above-mentioned procedures, we found that for the Contracts: 28T presented in the current report dated 22.01.2018; 48L presented in the Current Report of 07.02.2018; Contract 97L presented in the Current Report of 30.05.2018 and 145 L presented in the Current Report on 18.09.2018, the estimated values presented do not correspond to the contractual provisions. The errors found in the above-mentioned reports were corrected based on the Errata published on 08.05.2019

The prices related to the contracts included in the Current Reports from January 22, 2018, February 07, 2018, February 26, 2018, March 12, 2018, May 30, 2018, September 18, 2018, October, 02, 2018, October, 11, 2018, October, 26, 2018, October, 30, 2018, November, 14, 2018 have been established in accordance with the regulated tariffs by ANRE, through Order number 74/02.08.2017 and Order no. 98/2018. These tariffs are regulated and are not established under market conditions



Qualified conclusion

On the basis of the procedures and the evidence obtained, except for the effects described in the Basis for the qualified conclusion of our report, nothing came to our attention to make us believe that the transactions reported in the Current Reports from from January 22, 2018, February 07, 2018, February 26, 2018, March 12, 2018, March 13,2018, May 30, 2018, August 17, 2018, September 18, 2018, October 02, 2018, October 11, 2018, October 26, 2018, October 30, 2018, November 14, 2018 do not are in conformity, in all material respects, with the requirements of art. 82 of Law no. 24/2017 and art. 144 B) of Regulation no. 5/2018.

Other aspects

Our report was prepared exclusively for the purpose set out in the first paragraph and for informing the Company Management, the Bucharest Stock Exchange (BVB) and the ASF and cannot be used for other purposes. Our report should not be considered as suitable for use by any party wishing to acquire rights to us other than the Company for any purpose or in any context. Any party other than the Company who gains access to our report or a copy of it and chooses to rely on our report or part thereof will do so at its sole discretion. Our engagement has been undertaken to be able to report to the Company's Management those matters that we have to report in an independent, limited liability report, and not for other purposes. Our report only refers to the current Report mentioned above and does not extend to other Company reports.
