SNTGN Transgaz SA concluded a legal act of the type referred to in Article 234 (1) (i) of Financial Supervisory Authority Regulation No. 5/2018 on issuers of financial instruments and market operations.

According to Art. 234 (1) (i) of Financial Supervisory Authority Regulation No. 5/2018, SNTGN Transgaz SA is reporting a legal act whose value exceeds 10% of the net turnover for financial year 2023.

The scope of the contract is the loan amounting to lei 1.928.850.000 for financing/refinancing expenditure related to the following projects:

- Development on the Romanian territory of the Southern Transmission Corridor for taking over the Black Sea gas;
- DN 600 Mihai Bravu-Siliştea Gas transmission pipeline and changing into a piggable pipeline;
- Ghercești Jitaru gas transmission pipeline;
- Gas supply of Mintia Plant;
- Increasing the transmission capacity of the National Transmission System and the security of gas supply of the Electrocentrale Işalniţa Branch and the Electrocentrale Turceni Branch;
- Prunișor Orșova Băile Herculane Jupa gas transmission pipeline;
- BRUA Phase II; and
- any other project mutually agreed between SNTGN Transgaz S.A. and the Lenders and included in the Borrower's Development Plan approved by ANRE.
