

## As a Transmission System Operator, Transgaz performs the following activities related to gas transmission operation

### 1. Issuance of approvals regarding the Transmission System, according to the laws on the authorization of construction works execution

If following the receipt of the technical solution and the estimated work value, the requesting person decides to continue the changing of the Transmission System facilities by deviation with other economic operators, authorized by ANRE, the requesting person has to pay to the TSO the tariff for the activities performed by the TSO for the approval of the technical project, work surveillance and work acceptance:
