in accordance with Law No 185/2016 on certain measures necessary for the implementation of projects of national importance in the field of natural gas, the Ministry of Energy has been designated as the competent authority for issuing construction permits for projects of common interest in the field of natural gas.

By **ME Order no. 854/12.09.2017**, the Intermediate Body for Energy - APIC Department, received the task of carrying out the legal activity regarding the issuance of the construction permit for projects of common interest in the field of natural gas, consequently on 15.09.2017 *the construction permit was issued for the execution of the works related to the above-mentioned project.*

After analysis of the existing documentation submitted by S.N.T.G.N." TRANSGAZ" SA, the working group set up on the basis of the Order of the Minister of Energy no. 854/12.09.2017, found that part of the documentation needs to be completed according to legal requirements and in compliance with European standards.

In accordance with the operational procedure for the issuance of construction/dismantling permits PO-11.01, respectively the provisions of Law no. 185/2016, the Ministry of Energy sent to the project promoter, by letter no. 103948/TFP/04.10.2017, **the list of all the requirements that must be met, according to the law, within 6 months after the issuance of the construction permit ("submission of complete documentation")**.

within the legal deadline, S.N.T.G.N." TRANSGAZ" S.A. **submitted all the required documents to the competent authority**, so that the legal requirements applicable to the documentation for the construction permit were fully met.
