By Resolution 27 taken in the meeting held on 24 August 2020, the Board of Administration approved the Financial Statements of SNTGN Transgaz SA for Semester I 2020, prepared in accordance with the International Financial Reporting Standards adopted by the European Union.

In the same meeting the Board of Administration endorsed the Report issued by the Board of Administration of SNTGN Transgaz SA for the activity performed in Semester I 2020 for its submission to the Ordinary General Meeting of the Shareholders.

According to the capital market law, the unaudited Interim Financial Statements for Semester I 2020 contain:

The Interim Financial Statements for Semester I 2020 are not audited.

The economic and financial activity of the National Gas Transmission Company Transgaz S.A. between January 2020 and June 2020 was conducted based on the indicators included in the revenue and expense budget approved by OGMS Resolution No. 2/04.03.2020.

In Semester I 2020 operating revenue before the balancing and construction activity, according to IFRIC12 decreased by 2% as compared to Semester I 2019, which is lower by lei 15.965 thousand.

In Semester I 2020 operating costs before the balancing and construction activity according to IFRIC12 decreased by 8% as compared to Semester I 2019, which is lower by lei 42.961 thousand.

As compared to Semester I 2019 the gross profit obtained in Semester I 2020 increased by 20%, which is higher by lei 45.419 thousand, the net profit registered by the company being 231.168 lei.

Compared to the Revenue and Expense Budget for Semester I 2020, the gross profit increased by 152% as compared to the plan, which is higher by lei 167.379 thousand as compared to the REB, and the net profit increased by 139% as compared to the plan, which is higher by lei 134.617 thousand as compared to the REB.
