2. Results of Economic Tests

Offer Level 1.

For FGSZ, the economic test was passed. The required PVuc was HUF 1,665,050,988, while the actual PVuc calculated from the result of the capacity allocation was HUF 3,075,943,510.

For Transgaz, the economic test was not passed. The required PVuc was RON 168,703,581 RON while the actual PVuc calculated from the result of the capacity allocation was RON 12,822,982. The negative result of the economic test for Transgaz, calculated according to the provisions of CAM-NC, is determined by the reduced level of the requested incremental capacity, respectively the demand for incremental capacity was 70,550 KWh/h of the total offered incremental capacity of 4,334,308 KWh/h, inferior to the level of 70% provided for in the incremental capacity project.

The single economic test for Offer Level 1 was therefore not passed.

Offer Level 2.

For FGSZ, the economic test was not passed. The required PVuc was HUF 68,062,969,325, while the actual PVuc calculated from the result of the capacity allocation was HUF 0.

For Transgaz, the economic test was not passed. The required PVuc was RON 3,650,122,948 while the actual PVuc calculated from the result of the capacity allocation was RON 0.

The single economic test for Offer Level 2 was therefore not passed.

Offer Level 3.

For FGSZ, the economic test was not passed. The required PVuc was HUF 68,103,531,346, while the actual PVuc calculated from the result of the capacity allocation was HUF 0.

For Transgaz, the economic test was not passed. The required PVuc was RON 6,231,485,102 while the actual PVuc calculated from the result of the capacity allocation was RON 0.

The single economic test for Offer Level 3 was therefore not passed.

3. Conclusion of the Incremental Capacity Procedure

The Incremental Capacity Procedure is hereby terminated without any incremental capacity booking contracts concluded under the Incremental Capacity Procedure.
